Cookie Policy

These Cookie Policy were last updated on January 12, 2022, and apply to citizens and permanent residents of the European Economic Area.

- 1. Introduction Our website, https://www.simaplast.cz (hereinafter referred to as "the website"), uses cookies and other related technologies (for convenience, all technologies are referred to as "cookies"). Cookies are also placed by third parties we have engaged. In the document below, we inform you about the use of cookies on our website.
- 2. What are cookies? A cookie is a small, simple file that is sent along with the pages of this website and stored by your browser on your computer's hard drive or other devices. The information stored therein can be returned to our servers or to the servers of the relevant third parties during a subsequent visit.
- 3. What are scripts? A script is a piece of program code used to make our website function correctly and interactively. This code is executed on our server or on your device.
- 4. What is a web beacon? A web beacon (or a pixel tag) is a small, invisible piece of text or image on a website used to track traffic on the website. For this purpose, various data about you are stored using web beacons.
- 5. Cookies 5.1 Technical or Functional Cookies Some cookies ensure that certain parts of the website function correctly and that your user preferences remain known. By placing functional cookies, we make it easier for you to visit our website. This way, you do not need to repeatedly enter the same information when visiting our website. We can place these cookies without your consent.
- 5.2 Statistical Cookies We use statistical cookies to optimize the website experience for our users. With these statistical cookies, we gain insights into the usage of our website. We ask for your permission to place statistical cookies.
- 5.3 Marketing/Tracking Cookies Marketing/tracking cookies are cookies or any other form of local storage used to create user profiles to display advertising or to track the user on this website or across several websites for similar marketing purposes.
- 5.4 Social Media Buttons We have included content on our website to promote web pages (e.g., "like," "pin") or share (e.g., "tweet") on social networks. This content is embedded with code derived from third parties and places cookies. This content can store and process certain information for personalized advertising. Read the privacy statements of these social networks (which can change regularly) to understand what they do with your (personal) data processed using these cookies. The data obtained is anonymized as much as possible.
